Student webinar - Edition 2 !



Following the great success of the 1st student webinar dedicated to Pharmacokinetics professions organized in 2021 by the GMP, the 2nd edition is in preparation.

This year, pharmacokinetic professions in regulatory agencies, in pre-clinical and clinical development, or in modeling will be presented by professionals from the pharmaceutical industry and health agencies. The various university courses allowing you to specialize in pharmacokinetics will also be presented during this webinar.

Treatment individualization: improving interactions between industry and hospital

The satellite "Treatment individualization: improving interactions between industry and hospital", jointly organized by the GMP and the STP-PT group (dedicated to Therapeutic Drug Monitoring) SFP-PT the (French Society of of Pharmacology and Therapeutics), was held on October 20, 2021 (9h30 - 12h30) in the Espaces Diderot, just before the GMP annual meeting. In addition to the session's two moderators (Florence Gattacceca for the GMP and Romain Guilhaumou for the STP-PT) and the 10 people involved in the organization (Chadi Abbara, Vassilios Aslanis, Elisa Calvier, Etienne Chatelut, Jonathan Chauvin, Vincent Duval, Peggy Gandia, Nicolas Grégoire, Nassim Djebli and David Ternant), the session welcomed 10 other participants, juniors and seniors, from the pharmaceutical industry or academia.



To maintain and expand the dialogue initiated during this session, a commission on this topic will be created under the auspices of the GMP. If you would like to know more or become involved in this commission, you are most welcome! Just mail Florence Gattacceca :

The session began with an overview of the issues related to individualized dosing from both sides: medical practitioners and R&D industrials. This was followed by an animated and fruitful discussion on expectations and constraints of the various actors, and on actions to be taken to improve interactions between companies and hospitals in individualizing treatment.

Needs and obligations sometimes appeared contradictory: one part aiming to simplify drug administration (as stated in the Summary of Product Characteristics) for product marketing and respecting a certain degree of data confidentiality versus the other part willing to take into consideration patients' characteristics to optimize individual treatment. Nevertheless, all participants agreed that closer links and exchanges between R&D pharmacologists and their hospital counterparts could make it possible to improve individualization treatment with two complementary benefits: the first to improve drug benefit/risk balance, the second to possibly avoid treatment interruption patients with particularities that may pose problems when standard dose is used ..
